## FEDERAL REGULATION D ELECTRONIC TRANSFER FEES FOR SAVINGS ACCOUNTS:

Federal regulation D places a monthly limit on the number of electronic transactions you may make to or from your SAVINGS ACCOUNT. Savings accounts include all share and club accounts. This includes online banking transfers and automatic transfers to your checking account to cover overdrafts. All electronic transactions over 6 per month that affect your savings account will incur a charge of \$25 per

**transaction.** This rule does **not** apply to checking accounts. If you have a high volume of transactions from your savings account, consider opening a

checking account with us to avoid these fees.
